## American Rescue Plan Act (ARPA)

### Awarded for FY24/FY25

The Records, Communications and Compliance Division submitted a work program requesting \$20,853,829 in American Rescue Plan Act (ARPA) funds to continue funding the NCJIS Modernization Program for State Fiscal Years 2024 and 2025.

The request for the ARPA funding was heard at the State of Nevada's Interim Finance Committee on Thursday, October 20, 2022. The request for ARPA funding was approved by the committee.





**1 week prior** Additional information and assistance




